Introduction of concepts "risk-situation" and "risk-event" is proved. These concepts allow to consider complex character and necessary parametres of risks. Management process by risks-situations in organizational-technical systems is described. Set of fuzzy models for decision-making support on the basis of risks-situations is offered: model of risks-situations; estimation model of risks-situations; choice model of ranged groups of actions. The generalised algorithm of interaction of these models is described.
